# **Competitive Integrated Employment Grant (CIE)**

The district was awarded a \$30,000 grant from the Pennsylvania Department of Education (PDE) focused on improving competitive employment options for student with disabilities. There were an abundance of applications submitted by LEAs from across the Commonwealth that held merit and showed a commitment to expanding effective competitive integrated employment programs, so being selected as a recipient is quite an accomplishment. SEAC members were instrumental in helping to develop and write the grant proposal.

As part of this grant, the district is looking to establish partnerships with local businesses to provide expanded opportunities to students. The district is looking for businesses who would be willing to:

- **Business Tour/Visit:** Allow students to visit your business.
- **Job Shadowing:** Provide a student the opportunity to spend part of a day with a worker in the workplace.
- **Mentoring:** Provide a student the opportunity to spend part of a day on a weekly basis with a worker in the workplace.
- Work-Based Opportunities: Train a student on the job site.
- Advisory Committee Member: Serve as an advisor on program development.
- Career Awareness: Provide information about your profession in the school setting.
- Assist a Class: Be a guest speaker, assist with job search skills such as resume writing, job search strategies, interviewing.
